COMMUNITY INVOLVEMENT UPDATE

The ABA's Community Involvement Committee has been meeting with the Jefferson County, Wheat Ridge and Lakewood representatives for the purpose of changing the designation of Youngfield Street. The ABA is pleased that the designation has been changed to a three-lane street (one in each direction with a center turn lane). With this change, the ABA can proceed forward with the vision of a pedestrian/bike friendly street. The next step will be to talk with the property owners to discuss a design plan for Youngfield Street including curb and gutter storm drains and possibly underground electrical, and the redevelopment of existing property.
